Production Fee Scholarship Application

SYT is pleased to be able to offer a limited number of production fee scholarships through the fund-raising efforts of our Parents' Club. Applicants who can prove, via the Form 1040, that their household income falls under our maximum income threshold will receive a scholarship of **between \$75 and \$125 toward the production fee**. We believe that it is important that each family have some financial investment in their child's SYT experience, so we are not able to offer full scholarships.

Once this application and accompanying tax form are turned in to the SYT office, the applicant will be notified of the outcome by phone within three business days. The decisions of the scholarship committee are final.

In order to complete registration at that time, a mandatory, non-refundable \$25 registration fee will be due. The remaining balance of the production fee, if any, may be paid immediately, or via the installment plan listed on the other side of this sheet.

Production Fee Installment Payment Agreement

Installment Payment Plan: Any family may request to pay their production fee in installments. After submitting a **mandatory, non-refundable \$25 registration fee**, the family agrees to pay the remaining fees via a regular schedule of monthly VISA or Mastercard transactions. Here's how it works:

1. The applicant fills out the credit card information in the space provided below.
2. The applicant and SYT staff agree on a payment schedule, with each payment to be charged on or after the 5th of each month.
3. The applicant agrees that if the credit card transaction is declined for any reason, the balance of the production fee will be due immediately, and the participating student will not be admitted to rehearsal until this obligation has been taken care of.
4. SYT agrees to keep all credit card information secure, and will destroy this document once all payments have been made.
